### FINAL COMMENTS FROM THE BOARD CHAIR

As I finish my third year as your Board Chair and prepare to turn over the Chair position to the capable hands of Ron Phillippo, I want to thank you for your support. I can't leave without a final comment on fund raising for the Museum. Like all nonprofits, we face a constant battle to retain our current contributors and attract new ones. This economy has made it difficult for everyone. However, on the upside, we have a growing number of enthusiastic and dedicated supporters.

Some of you may be thinking, "In this economy, I cannot afford to give right now." I find myself in that same boat. Without new income, it is difficult to find additional funds to increase a sustaining membership or even make a substantial year end gift. However, there is a way you can ensure the future of the Museum without it costing you a cent right now.

That method is called Planned Giving through a bequest from your estate. A bequest to the Museum is a gift from a donor's estate. It can be a gift of cash, assets, or retirement funds, of a specific amount, or a remainder percentage of the estate. The legacy value of a bequest is immeasurable. Bequests assure donors that a beloved charity will continue beyond their lifetimes and might provide more assistance than donors are able to provide during their lifetimes.

Look at my own situation: I have a significant amount in IRAs for which I am required to take a minimum distribution yearly. Some of what is left at the end of my time on this planet has been left to the Museum in the hope that my grandchildren will always be able to remember what Scouting meant to their grandparents, parents and siblings and how it helped them develop into the people they are today.


It is a very simple process to leave all or part of your IRA to the Museum. You do not have to change your will. You simply change the beneficiary on the IRA and let Claudia know that you have done this.

### **VOLUNTEER CORNER**

This article is the fifth in our series featuring volunteer staff at the Museum.

Becca Emmons "just dropped out of the sky" when she joined the Museum in 2007, as Claudia Nicholson describes it. Becca recounts that one of her reasons for joining the Museum was her early life experiences as a Girl Scout in both Minnesota and New York. Becca was a Girl Scout for a little over five years. Claudia recalls showing her around the Museum sometime in 2008 and describing potential projects to her as a prospective volunteer.

Among the projects that Claudia mentioned at that time was pulling together the records of the North Star Scouting Memorabilia, Inc. organization. Becca expressed interest in the project. About three years later she returned and started working on this project. It is important to note that the Museum's forty years of records were scattered over and in several locations, in boxes and drawers and even in piles on the floor. In addition to being scattered about, the records were not in any particular order. For example, board minutes were commingled with donation documents, financial records, general correspondence, and membership information, sometimes all in one box spanning many years!

Successful volunteer recruitment and retention involves an organization finding the best fit for the volunteer and his or her skills, interests and available time. It has been our good fortune that Becca Emmons comes to the Museum with a master's degree in Library Science and a stated desire to "create order" out of disorder. She went on to say, "I love problem solving and detail work." We have found a perfect volunteer match in Becca! In just over two years of volunteering, Becca has gone through nearly all forty years' worth of records. Becca indicates that some of the Museum's earliest records start in about 1974. She has identified hundreds of records that we no longer need and has made it possible to find our organization's important documents, such as board of director minutes, committee records and newsletters, quickly and easily!

Recently Becca worked to update a guidebook that expands our record retention policy. She also developed a guidebook and checklist of what to keep and what to discard on an annual basis. The Board recently approved these new policies. These important tools will be used by future staff, committee members and volunteers. Becca finds her work very interesting. Finding out about the Museum's early history is part of the satisfaction she gets from her volunteer role. Becca also enjoyed her consultations with Claudia on the document retention policies and guidebook.

Becca has been one of the Museum's regular volunteers, coming in almost every week and working for three or four hours at a time. She puts in well over a hundred volunteer hours each year—wow! When asked to describe one or more interesting events as a Museum volunteer, Becca recalled finding a 1974 letter from the Museum's very first cash donor. In that thirty-eight-year-old letter, the donor stated that if the Museum needed more help in the future, just ask. When Claudia saw the letter she had a vague hunch it might be worthwhile to find this donor. To everyone's surprise, she was able to make contact with him. Even more amazing, he gave us another substantial donation after all of these years.

Through her outstanding work, Becca has become the Museum's organizational historian and record keeper. Thank you Becca!
